HOA Budget & HOA Board Positions

Covenant Enforcement

A primary role of the HOA Board of Directors is to ensure that our Protective Covenants are followed by all residents and enforced in an even-handed manner. In prior letters I have explained our enforcement procedures, so I won't take up space here. If you have questions you contact me or Bernie Dickson at CAS.

At our June HOA Board meeting three residents addressed the Board about their concerns with boats and trailers remaining in driveways overnight in violation of the Protective Covenants. We had a

productive and rational discussion about these violations and looked at the issue from the perspective of the boat owners and residents. The Board decided to undertake a renewed Covenant enforcement effort with CAS issuing appropriate warning or Adjudicatory Hearing notices to residents who persist in parking boats and trailers overnight in their driveways.

When it comes to Covenant violations, the HOA Board's only option, if it is to be true to its responsibilities, is to enforce the Covenants as written. Our goal is Covenant compliance and not punishment. However, the Adjudicatory Committee exists to address uncorrected Covenant violations and can assess penalties of up to \$100 per day for continuing violations. The Covenants apply to all residents and exist to protect and preserve the nature of our community.

Taberna Townes

We are inching closer to the goal of CresCom Bank being able to sell the Taberna Townes development to a developer to complete the buildout of this sub-association. When the Taberna Townes project was initially started in 2006, the then developer proceeded to build Battlefield Trail (the entranceway road) without the proper easements from the NC Railroad. The absence of an approved easement is a deterrence to any prospective developer.

The HOA, CresCom Bank, the North Carolina Railroad and the City of New Bern have agreed in principle to a solution to this problem that will grant a permanent easement from the Railroad for the utilities running under Battlefield Trail, a license that permits the current use of Battlefield Trail, and the reservation of space for an alternative entrance to Taberna Townes in the unlikely event the Railroad needs to expand and use the area currently occupied by Battlefield Trail. We hope to be able to finalize the necessary documents in the next 60 days.
