number. The only item passed to the list server will be your e-mail address. Your physical address is needed to confirm your status as a Taberna resident or property owner. In the event, you choose not to give your telephone number, note that if there is a problem with your e-mail address, i.e., bounced e-mails, we have no way to contact you to resolve the problem. Covenant Enforcement During Disaster Recovery

In the interest of helping to minimize the pain associated with recovery from Hurricane Florence and storm related issues, the HOA Board and CAS will, until December 15th, suspend the application of certain specific Covenant restrictions as they pertain to short-term property rentals (i.e., less than one month), recreational vehicles and campers, utility trailers, dumpsters, and storage containers in driveways and/or on the streets. We will review the situation again at our November HOA Board Meeting. Note that this is only for storm related recovery. The Covenant restrictions pertaining to boats in driveways and streets is still in effect.
