#### Accounts Receivable - Aging -

Summary Taberna Master HOA & Sub-communities –

With the second quarter ending, the Financials remain favorable. Actuals are at or below the Budget through this period. The rate of delinquency has remained constant these past two months. Eleven Homeowners contribute to more than 75 percent of the Aging Accounts Receivable total of \$13,300. Legal action is in the process or is being pursued to resolve these areas. The Emergency Fund Equity stands at \$62,300 inclusive of an insurance payment of \$27,600. To date, almost \$60,000 had been expended because of Hurricane Florence; little remains to be repaired or replaced.
