He believes he is qualified to be a Board member because he is able to listen to ideas and think outside the box, give feedback on an idea, as well as, pitch issues that may be encountered and solutions to correct them. He also wants to bring some new life and younger ideas to the Board. His priorities are:

- a) The impact on the community of the sale of the Taberna Country Club and
- b) Enforcing the Covenants to keep the community welcoming and clean.

### Wayne Maruna

Wayne spent a career with Moen Incorporated as a plant and division controller and is well versed in budgeting, financial controls and general business acumen. Wayne's top priorities for the Board are:

- a) Represent and protect the interests of the residents through the roll-out of the Highway US-70/ I-42 project and
- b) Continue to monitor and promote the viability of the Taberna Country Club
