## Taberna Homeowners Association Board of Directors Meeting Minutes July 6, 2004

## **OPEN ITEMS**

Minutes from the June 1<sup>st</sup> board meeting were approved as submitted. The minutes from the June 16<sup>th</sup> meeting with the Young Peoples group were approved as submitted.

John Murphy updated the Board on the following items:

- Storm Water permits transfer is still being worked on. No change in status since last month
- Crime Watch committee is still looking for a chairperson.
- The monuments depicting the subassociation areas should be covered in the budget for periodic cleaning. There is money set-aside in the Buildings and Grounds budget for landscaping around the monument in Abbington Woods

Discussion was held on the privacy fencing in the Abbington Woods area. The Abbington Woods covenants clearly states that privacy fencing would be erected. There are two homes that refuse to have the privacy fencing erected. Last year's board gave their support of the Abbington Woods covenants. Ron McClausland has expressed his concern that no progress has been made to enforce this ruling. The current board agreed to take this under advisement and to tabled further actions at this time.

John Galvanek gave the Board an update on the Emmons berm and construction entrance off of Old Airport Road. The sub-contractor removed the gate at the construction entrance. Rick Scheper will work with the sub-contractor to block the construction entrance.

The Emmons berm has been landscaped. Scheper will order the fencing for the berm. There is a gap in the berm that is causing water to run into Wentworth's property.

John Galvanek stated that we would discuss 2<sup>nd</sup> quarter budget results at the next Board meeting.

John Galvanek updated the Board on the status of delinquent accounts. Don Hughes agreed to assist John in placing liens on the property if the account remained delinquent. A motion to place liens on the delinquent account was made, seconded and passed.

Esther Hardin provided the Board with information on the Greenbrier "Loan Closet". A brief discussion followed and Esther will write an article for the Taberna Tribune to see if there is any interest in formalizing a Taberna Community "Loan Closet".

John Murphy stated that the lots on Teufen Road will be bush-hogged. Also contractors must have signs that conform to the Taberna covenants regulations.

John Galvanek will establish a Taberna Tribune budget for the remainder of 2004 and for 2005.

## **NEW BUSINESS:**

James Russo, in a letter to Bill Rounds dated May 2, 2004, recommended that the assets held in reserve accounts be transferred into higher paying savings accounts. A motion to transfer \$25,000 of reserve monies to ING Direct was made, seconded and passed.

Danny Meadows from the City of New Bern, wants to meet with Bruce Gemmill to discuss the streets in Taberna. Dennis Burke from the Buildings and Grounds committee and Larry Alderson and/or John Galvanek will also be at this meeting.

The next board meeting was set for Monday, August 9<sup>th</sup> at 4p at the HOA Office.
